ADELAIDE WILDCATS NETBALL CLUB

Adelaide Wildcats Netball Club has developed this fee policy after careful consideration. Non payment of fees places a financial burden on the club which then impacts on our ability to undertake activities which would benefit players. It also places an extra workload on the Committee whose time can be better spent on the growth and development of the Adelaide Wildcats Netball Club. If you have any concerns about these guidelines, please contact a member of the Committee who should be able to assist you with your query.

FEE POLICY GUIDELINES

- This policy applies to all members of Adelaide Wildcats Netball Club (AWNC)
- All players are required to complete a player registration form accompanied by a trial fee amount as set by the committee.
- Failure to pay a trial fee will result in the player being unable to participate in trials.
- The trial fee will be NON refundable if the player chooses not to play for AWNC.
- Season fees will be reduced by the amount of the trial fee if the player is selected in a team.
- If AWNC is unable to place the player in a team the trial fee WILL be refunded in full.
- The balance of season fees and uniform items are to be paid by 5th game of the season. If fees remain unpaid by this date or a payment plan has not been negotiated with the Treasurer, the player will be unable to take the court until all fees are finalised.
- No player can participate in finals unless they are financial, that means all fees fully paid. Payment plans will have to be completed before finals participation by the player.
- Players who are unfinancial will be ineligible to receive awards at our annual Presentations.
- In the event of unpaid fees being put in the hands of our Debt Collectors, any additional costs associated with this will be the responsibility of the player.
- Netball SA will be notified of any player in debt. This will prevent them from playing netball in any Netball SA affiliated competition until the debt to AWNC is cleared.
